ARTICLES OF ORGANIZATION

The undersigned, being a member or duly authorized representative of a member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company is Springboard Ventures I, LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the Company's principal office is:

ARTICLE III - COMMENCEMENT OF EXISTENCE

The Company will exist perpetually, commencing on February 13, 2002, unless the filing of these Articles of Organization occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Articles of Organization with the Secretary of State of the State of Florida.

ARTICLE IV - CONTINUATION OF LIMITED LIABILITY COMPANY

Except as set forth in the Company's Operating Agreement, so long as the Company continues to have at least one remaining member, the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution.

ARTICLE VI - MANAGEMENT AND AUTHORITY

The Company shall be a member-managed company; however, the Operating Agreement of the Company (a) restricts the authority of members to make investments or to incur debt or contractual liability on behalf of the Company solely by virtue of being a member without certain approvals of the members and (b) provides for a member-manager to act as the Administrator (initially designating Invest in North Florida, Inc.) with authority to certify compliance with the Operating Agreement and authority to act on behalf of the Company.
