ARTICLES OF CORRECTION TO THE ARTICLES OF ORGANIZATION OF
GUTELMAN, COELLO, BEBCHIK CONSTRUCTION, LLC.

The original Articles of Organization were filed with the Secretary of State of Florida on February 15th, 2002, and a copy of the Articles of Organization filed with the Secretary of State are attached as Exhibit A. The undersigned, acting as the members of GUTELMAN, COELLO, BEBCHIK, CONSTRUCTION, LLC., duly execute, file and adopt, pursuant to the Florida Limited Liability Company Act, the following Articles of Correction to the Articles of Organization:

ARTICLE I.

MANAGEMENT

Article VI of the original Articles of Organization shall be corrected to reflect the title of Management and to state the following: "The Limited Liability Company shall be managed by one or more managers. The original managers shall be: Dario Gutelman, Arthur Coello and Ricardo Bechik. Mr. Arthur Coello's name was misspelled as Arturo Cuello, in the original Articles of Organization. This article is intended to correct these typographical errors in the original Article VI of the Articles of Organization.

ARTICLE II.

DEFECTIVE SIGNATURE

The signature of Mr. Ricardo Bechik was defective as a Member in the original Articles of Organization filed with the Secretary of State. Mr. Bechik's signature was meant to be as the Authorized Representative of the other Member of Gutelman, Coello, Bechik Construction, LLC., a Florida limited liability company, Valentin Gutelman U.S.A. Corp., a Florida corporation, and not as a member of the LLC himself.

Mr. Coello's last name was misspelled on his signature line as Cuello, and this article is intended to reflect this correction.


