ARTICLES OF ORGANIZATION

OF

COMPUTER CONSULTANTS INTERNATIONAL (CCI) ENTERPRISES, L.L.C.

A Florida Limited Liability Company

The undersigned, acting as the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for **COMPUTER CONSULTANTS INTERNATIONAL (CCI) ENTERPRISES, L.L.C.** (the "Company"):
