

ARTICLES OF ORGANIZATION
OF
COMPUTER CONSULTANTS INTERNATIONAL (CCI)
ENTERPRISES, L.L.C.

A Florida Limited Liability Company

The undersigned, acting as the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for **COMPUTER CONSULTANTS INTERNATIONAL (CCI) ENTERPRISES, L.L.C.** (the "Company"):

ARTICLE ONE

NAME

The name of the Company is **COMPUTER CONSULTANTS INTERNATIONAL (CCI) ENTERPRISES, L.L.C.** and its principal place of business shall be in the City of Boynton Beach, County of Palm Beach, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE TWO

DURATION

The limited liability company shall exist until dissolved in a manner provided by law, or as provided in accordance with the regulations adopted by the Members.

ARTICLE THREE

ADDRESS

ARTICLE FIVE

MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

ARTICLE SIX

INDEMNIFICATION

To the fullest extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she is or was a manager, managing member, registered agent, or officer of the Company or is or was serving at the request of the Company as a manager, managing member, director, registered agent, officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The Company shall reimburse each person for all costs and expenses, including without limitation, attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, in accordance with Florida Statutes Section 608.407(3), being a member of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of **COMPUTER CONSULTANTS INTERNATIONAL (CCI) ENTERPRISES, L.L.C.**

In accordance with Section 608.408(3), Florida Statutes, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true.


