**ARTICLES OF ORGANIZATION
Of
TVR LEASING, LLC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – Name

The name of the limited liability company shall be **TVR LEASING, LLC.**

ARTICLE II – Address

ARTICLE III – Duration

The limited liability company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The limited liabilities existence shall be perpetual unless the limited liability company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV- Registered Office and Agent

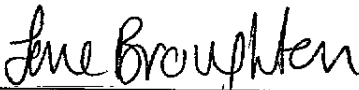
ARTICLE VII- Members' Right to Continue Business

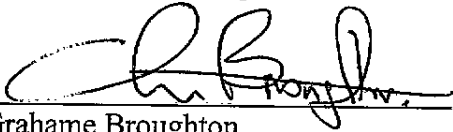

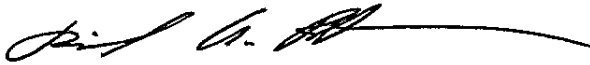
