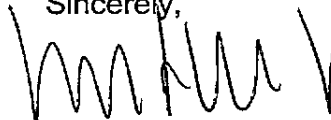

ARTICLE I - Name

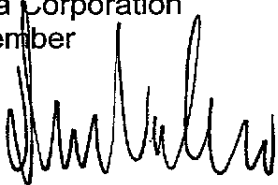
The name of the Limited Liability Company is **amended to WICKHAM DRUGSTORE, LLC** (the "Company").

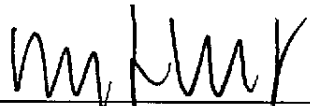
