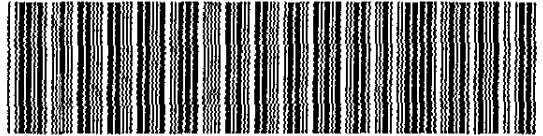

TO
