**SIXTH:** The person or persons executing these Articles of Organization are members or the authorized representative of a member of the Limited Liability Company.

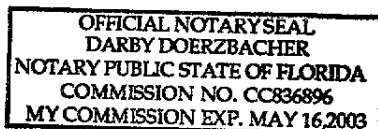
