The mailing address and street address of the principal office of the Company is 5373 Fairfield Way, Fort Myers, Florida 33919.


**ARTICLE III



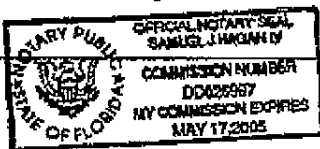
