## ARTICLES OF ORGANIZATION

OF

### ARTICLE I - NAME

## ARTICLE VII - ADMISSION OF NEW MEMBERS



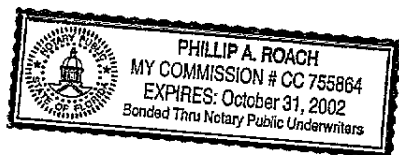
