**ARTICLES OF ORGANIZATION OF  
AC LASERS, LLC**

The undersigned, being authorized to execute and file this Articles, hereby certifies that:

**ARTICLE I**

Name

The name of the limited liability company ("Company") is AC Lasers, LLC.

**ARTICLE II**

Address

The mailing and street address of the Company's principal office is 1415 Foundation Park Boulevard, S.E., Palm Bay, FL 32909.

**ARTICLE III**

Duration

The Company shall have a perpetual existence, unless dissolved upon the written consent of all of its members or on the occurrence of the death, bankruptcy, resignation, or expulsion of the last one of its members. If, however, within the following 90 days, the personal or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of it or its nominee as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.

**ARTICLE IV**

Registered Agent and Office

The name of Company's initial registered agent in Florida is Michael A. Lupo. The address of Company's registered office in Florida is 1415 Foundation Park Boulevard, S.E., Palm Bay, FL 32909.

**ARTICLE V**

Management

The Company is to be managed by a Board of Managers the size of which shall be determined by the members. The initial manager will serve until the first annual meeting of the members. ## ARTICLE VI

### Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the consent of a majority in interest of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

## ARTICLE VII

### Members' Rights to Continue Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

## ARTICLE VIII

### Limitation on Agency Authority of Members

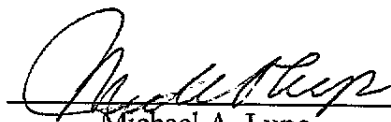
Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

## ARTICLE IX

### Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article V, subject only to the right of a majority of the members of the Company to amend, alter, or repeal the same.

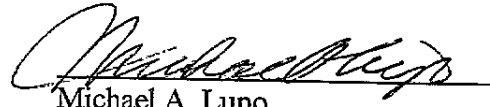
