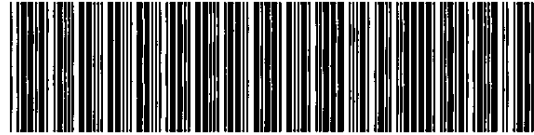

The undersigned, as sole Manager of the Company has executed these Articles of Amendment of the Articles of Organization on April 18, 2006.

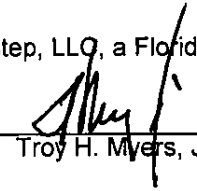
