



In January (2009), I advised you that the above Registered Agent was in violation of the law by not making himself available for service of process. You followed up on my complaint by notifying him of this violation (copy attached).

I would like to know if he has responded to your follow up so I can try to get process served for the third (3rd) time.

Also, I have found several other L.L.C. and/or corporations where Mr. James McArthur represent himself as their registered agent. Although some are out dated, or he failed to re-new or file an annual report, there is one, (REALTYRESOLVE.COM. L.L.C. Document Number L08000079659) he has renewed the annual report for, and list the same address where I was attempting to serve him. It stands to reason that if he wasn't available to accept process from me, he is doing the same thing to everyone else. I want to know if further follow up via Attorney General's office is possible as this is an on going violation of the law.
