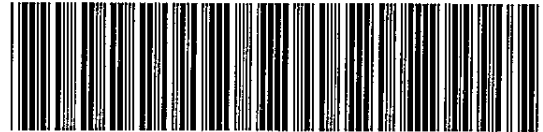

ARTICLES OF ORGANIZATION OF SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

(A Florida Limited Liability Company)
