

**ARTICLES OF ORGANIZATION OF
BWLK PROPERTIES, LLC**

ARTICLE I – NAME

The name of the Limited Liability Company is: BWLK PROPERTIES, LLC

ARTICLE II – DURATION

The Company shall terminate thirty years from the date of filing of these Articles of Organization with the Secretary of the State of Florida.

ARTICLE III – PURPOSE

The Company shall have the power to engage in any lawful act for which limited liability companies may enter according to the laws of the State of Florida, including powers now and in the future permitted by law.

Transfer of ownership interest shall only be done by cancellation of an existing Certificate of Membership Interest and issuance of another Certificate of Membership Interest. The Company shall keep a registry of all Certificate of Membership Interest issued by the Company.
