ARTICLES OF ORGANIZATION FOR CELL RECORDS, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") acting as the organizer and as the initial member of Cell Records, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:
