ARTICLES OF ORGANIZATION

The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be STORAWAY - TAVARES, LLC.


ARTICLE VI - ADMISSION OF NEW MEMBERS
