of

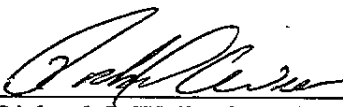

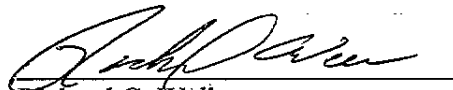
