**ARTICLES OF ORGANIZATION
OF
COSCIA L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is **COSCIA L.L.C.**

**ARTICLE II
DURATION**

The limited liability company shall have perpetual duration.

**ARTICLE III
PRINCIPAL PLACE OF BUSINESS AND ADDRESS**

The address of the principal office of the Company is 900 Twelve Oaks Drive, Winter Haven, Florida 33880, and its mailing address is the same.

**ARTICLE IV
PURPOSES AND POWERS**

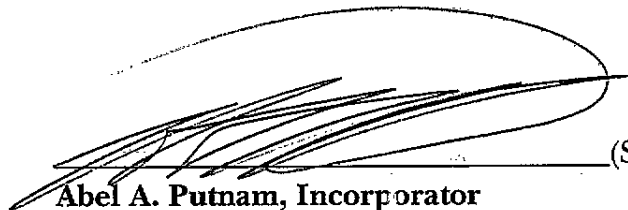
ARTICLE VI

IN WITNESS WHEREOF, the undersigned, as incorporator, hereby executes these Articles of Organization this 19th day of February, 2002.

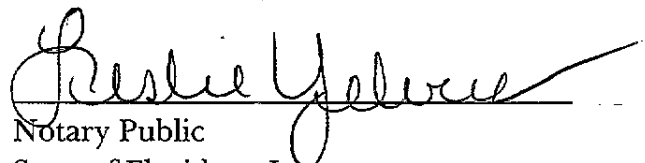
