**ARTICLE VI — Operating Agreement:**



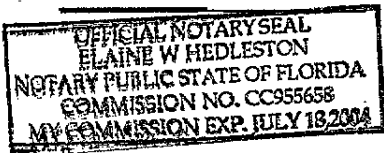


