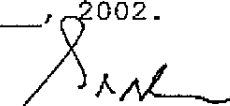
ARTICLE XI - TERMINATION OF A MEMBER

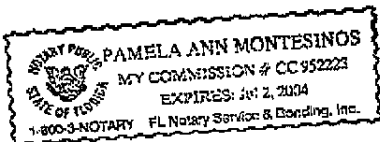

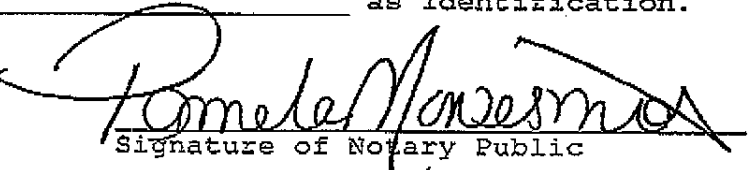
