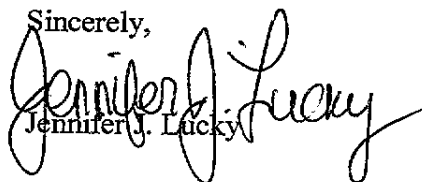

### **ADMISSION OF NEW MEMBERS**

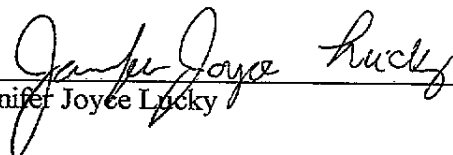
