ARTICLES OF ORGANIZATION

OF

KEVIN K. ROSS, PL.

These Articles of Organization dated February 20, 2002 are being filed by the undersigned Authorized person, for the specific purpose of forming a professional limited liability company under the provisions of §608 of the Florida Business Corporation Act and §621 of the Professional Service Corporation Act as follows:

ARTICLE I

The name of this professional limited liability company is **KEVIN L. ROSS, PL.**, (the "Firm").

ARTICLE II

The Firm's mailing address and the address of its initial principal office and initial registered office is 12212 Shadow Brook Lane, Orlando, Florida 32828 in Orange County, Florida. The initial registered agent at that address is Kevin K. Ross. The Firm may change its offices to such other places within the State of Florida as determined by its sole Member.

ARTICLE III

The general purpose for which the Firm is organized is to engage in every aspect of the practice of law as permitted by the laws of the State of Florida. The professional services involved in the Firm's practice of law may be rendered only through its Members who are duly authorized and licensed to practice law in the State of Florida. The Firm shall not engage in any business other than the practice of law. The Firm will commence existence upon the execution of these Articles of Organization and will continue until terminated in accordance with the Firm's Operating Agreement. The Firm will adopt an Operating Agreement to govern and regulate the management of the Firm's business and other affairs consistent with these Articles of Organization and applicable Florida law.

ARTICLE V

The Firm will be managed and governed by its sole member in accordance with the Firm's Operating Agreement. The name and address of the Firm's sole member is: Kevin K. Ross, 12212 Shadow Brook Lane, Orlando, Florida 32828.
