**ARTICLES OF ORGANIZATION
FOR
THE JUBILEE FRUIT BAR COMPANY, LC**

ARTICLE I

The name of this Limited Liability Company is: The Jubilee Fruit Bar Company, LC (hereinafter referred to as the "Company").

ARTICLE II

The street address and mailing address of the principal office of the Company is 2320 South 3rd Street, Suite 11, Jacksonville Beach, Florida 32250.

ARTICLE III


