OF

ANCHOR V, L.L.C.

REGISTERED OFFICE AND AGENT



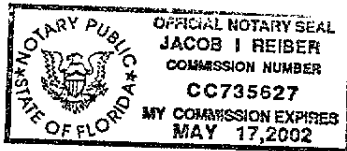


