ARTICLES OF ORGANIZATION

FOR

RIVERSIDE HOMES OF SOUTH FLORIDA, L.L.C., a Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute § 608 entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:


