# ARTICLES OF AMENDMENT to AMENDED AND RESTATED ARTICLES OF ORGANIZATION of RIVERSIDE SPINE & PAIN PHYSICIANS, P.L.

Pursuant to the provisions of Chapter 605, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Amended and Restated Articles of Organization:

- 1. The name of the limited liability company is Riverside Spine & Pain Physicians, P.L. (the "LLC").
- 2. The effective date of filing of the Amended and Restated Articles of Organization of the LLC was July 11, 2005 (the "Articles").
- 3. The LLC deems it to be in its best interest to amend Article I and Article VIII of the Articles.
- 4. That Article I and Article VIII of the Articles of the LLC are hereby amonded in its entirety to read as follows:

#### ARTICLE I NAME AND PRINCIPAL OFFICE
