ARTICLES OF AMENDMENT
to
AMENDED AND RESTATED ARTICLES OF ORGANIZATION
of
RIVERSIDE SPINE & PAIN PHYSICIANS, P.L.

Pursuant to the provisions of Chapter 605, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Amended and Restated Articles of Organization:

1. The name of the limited liability company is Riverside Spine & Pain Physicians, P.L. (the "**LLC**").
2. The effective date of filing of the Amended and Restated Articles of Organization of the LLC was July 11, 2005 (the "**Articles**").
3. The LLC deems it to be in its best interest to amend Article I and Article VIII of the **Articles**.
4. That Article I and Article VIII of the **Articles** of the LLC are hereby amended in its entirety to read as follows:

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of this Limited Liability Company is RIVERSIDE SPINE & PAIN PHYSICIANS, LLC (the "**Company**") and its principal address is located at and its mailing address is 7207 Golden Wings Road, Suite 100, Jacksonville, Florida 32244.

ARTICLE VIII
REGISTERED OFFICE AND AGENT

The street address of the registered office of the Company is 7207 Golden Wings Road, Suite 100, Jacksonville, Florida 32244, and the name of the registered agent of the Company at that address is J. Adam Steiger. The members shall have the power to establish branch offices and to move the principal office to any other address in Florida.

5. The foregoing amendments shall become effective as of the date these Articles of Amendment are filed with the Secretary of State of Florida.
