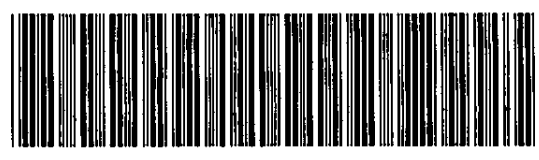



**ARTICLES OF AMENDMENT**

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**

**RIVERSIDE SPINE & PAIN PHYSICIANS, LLC**

Pursuant to the provisions of Chapter 605, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment (these "*Articles of Amendment*") to its Amended and Restated Articles of Organization:

1. The name of the limited liability company is Riverside Spine & Pain Physicians, LLC (the "*Company*").
2. The effective date of filing of the Amended and Restated Articles of Organization of the Company was July 11, 2005 (as amended, the "*Articles*").
3. That Article III and Article VI of the Articles are hereby amended as follows:


Article III – Powers

To have, in furtherance of the organizations purpose, all of the powers conferred upon Limited Liability Companies organized under the Florida Revised Limited Liability Company Act, subject to any limitations contained in these Amended and Restated Articles of Organization.

The Company is a member-managed limited liability company.
