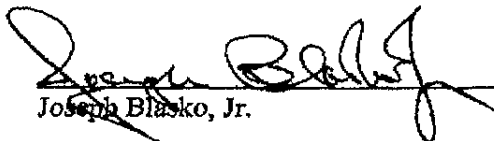
Article VII

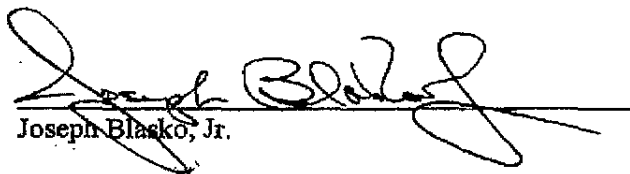
