FIRST: The name of the Limited Liability Company is **LUCKY US, LLC**.

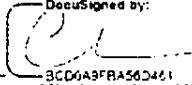
SECOND: The Articles of Organization of the Limited Liability Company were filed on March 4, 2002 and assigned document number L02000005072.
