The mailing address and street address of the principal office of the Company is 10165 N.W. 19th Street, Miami, Florida 33172.

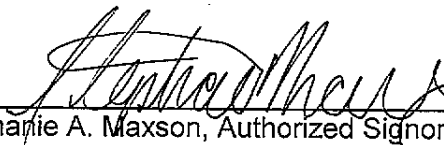
ARTICLE III - Registered Agent and Office
