**ARTICLES OF ORGANIZATION  
OF  
ROHR Associates, LLC  
a Florida limited liability company**

The undersigned, being the members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I  
NAME**


