ARTICLES OF ORGANIZATION OF HOME BUYERS OF RIVER CITY, LLC

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be HOME BUYERS OF RIVER CITY, LLC, and the mailing address and street address of its principal office shall be 4433 Meadow Creek Circle, Sarasota, Florida 34233, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

MEMBERSHIP RESTRICTIONS
