The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I-NAME

The name of the limited liability company shall be Ford Entertainment Enterprises, L.L.C. ("Company").

ARTICLE II-ADDRESS

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager or on the occurrence of any other event that terminates the continued membership of a member in the Company unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.
