**ARTICLES OF ORGANIZATION  
FOR**

**G-BIRD, LLC**

ARTICLE I

NAME

The name of the limited liability company is G-BIRD, LLC (hereinafter referred to as the "Company").

ARTICLE II

ADDRESS

The mailing and street address of the Company's principal office is 1934 Seclusion Drive, Daytona Beach, Florida 32128.

ARTICLE III

PURPOSE AND POWERS

Except as restricted by these Articles of Organization, this limited liability company is organized for each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

Except as restricted by these Articles of Organization, this limited liability company shall have and may exercise all powers and rights which a limited liability company may exercise under Florida law or the laws of the United States of America.

ARTICLE IV

DURATION

The period of duration for the Company is thirty (30) years or until dissolution pursuant to the Company's regulation; beginning on the date these Articles of Organization are filed by the Florida Department of State.

## ARTICLE VI

### MANAGEMENT

The Company is to be managed by its members and is, therefore, a manager-managed Company. This Company shall initially have two (2) managers. The names and address of the initial managing members are identified as follows: ROGER JONES and GERALD SCHEID.

## ARTICLE VII

### ADMISSION OF NEW MEMBERS

The members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine of the amount and nature of contributions by new members at the time the new members are admitted.

### CONTINUATION OF BUSINESS

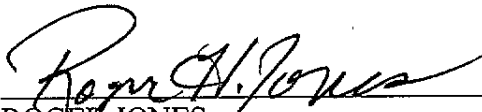

The power to adopt, alter, amend, or repeal any provision contained in these Articles of Organization or the regulations of the Company is vested entirely in the managers listed above in Article VI herein, and only by unanimous written consent, in accordance with the Florida Limited Liability Company Act.

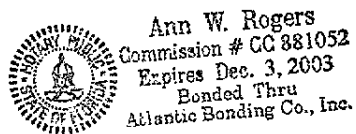

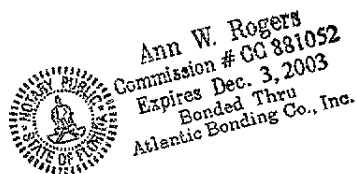

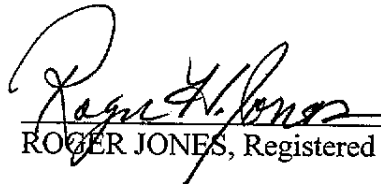
