**ARTICLES OF ORGANIZATION  
OF  
TAX & ACCOUNTING SOLUTIONS, L.L.C.**

**The undersigned**, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Fla. Stat. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be TAX & ACCOUNTING SOLUTIONS, LLC.

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company shall be 15881 Shamrock Drive, Fort Myers, Florida 33912.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are executed by the members. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in these articles of organization.
