ARTICLES OF ORGANIZATION OF LIVE OAK II, LLC

The undersigned, James J. Taylor Jr., who is the authorized representative of the belowidentified limited liability company, and of the members thereof, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Live Oak II, LLC ("the Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company is 7305 N. W. 294th Terrace, High Springs, Florida 32643.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization or in the Company's operating agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- COMPANY TO BE MANAGED BY MEMBERS

The Company shall be managed by its members in accordance with the operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
