ARTICLE V – EFFECTIVE DATE

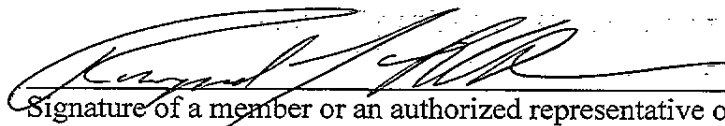
The effective date of the Limited Liability Company is March 1, 2002.

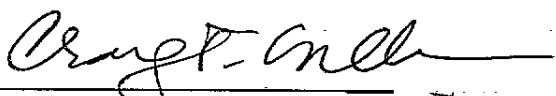
