ARTICLES OF ORGANIZATION

OF

MID FLORIDA RESTAURANT GROUP, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

Article I - Name

The name of the limited liability company shall be MID FLORIDA RESTAURANT GROUP, L.L.C. ("Company").

Article II - Address

The mailing address and street address of the principal office of the Company is 4109 W. Riverside Drive, Fort Myers, Florida 33901.

Article III - Duration

Article VII - Management


The company is to be and shall be managed, in accordance with Operating Agreement for the Company, by a manager, and the name and address of the manager is:
