**ARTICLES OF ORGANIZATION
OF
VERNACULAR LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be VERNACULAR LLC ("Company").

ARTICLE II

Address. The mailing address of the Company shall be Post Office Box 691625, Orlando, FL 32869-1625, and street address of the principal office shall be 6872 Bittersweet Lane, Orlando, Florida 32819.

ARTICLE III

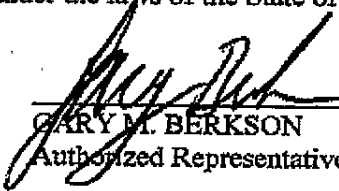

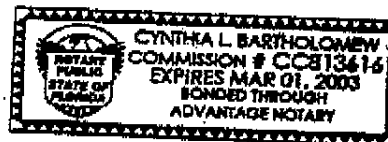

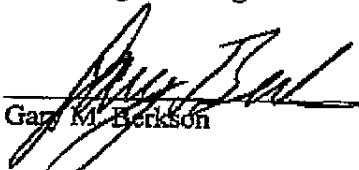
