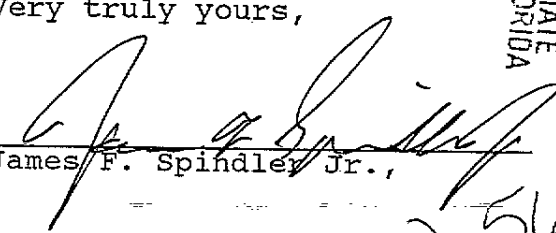

**ARTICLES OF ORGANIZATION  
FOR  
K2 TRUCKING LLC  
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a Limited Liability Company Act, do hereby adopt the following Articles of Incorporation for such company:

**1. NAME.** The name of this company shall be K2 TRUCKING INC., a Florida Limited Liability Company.

**2. DURATION/CONTINUATION.** The period of the company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the company subsequent to the foregoing events.

#### 8. OPTIONAL PROVISIONS:

**AMENDMENT OF ARTICLES OF ORGANIZATION.** Any Amendment to these Articles of Organization shall be on such form prescribed by the Secretary of State of the State of Florida containing such terms and provisions consistent with Florida Statutes 608 as shall be prescribed by the Department of State, and shall be signed and sworn to by all members of the company. In the event a new member is added by such amendment, it shall be also signed by the member to be added.

**REGULATION OF COMPANY.** The power to adopt, alter, amend or repeal the Operating Agreement and Regulations of the Limited Liability Company shall be vested in the Members unless vested in the Managers of the company by any amendments of the Articles of Organization. The Operating Agreement and Regulations adopted by the Members or by the Managers may be repealed or altered, a new Operating Agreement and Regulations may be adopted by the Members and the Members may prescribe in any Operating Agreement and Regulations made by them that such Operating Agreement and Regulations may not be altered, amended or repealed by the manager.

**INFORMAL ACTION OF MEMBERS.** Any action of the members may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all Members who would be entitled to vote upon such action at a meeting (and filed with the Manager of the Company as part of its records).

**CONTRACTING DEBT.** Except as otherwise provided by Law, debt shall be contracted nor liability incurred by or on behalf of this company except by the Manager or if managed by the Members, by any member of this Company, unless otherwise provided herein.

**TRANSFERABILITY OF MEMBERS INTEREST.** An interest of a Member of this company may be transferred or assigned to such extent and in the manner provided in the Operating Agreement. However, if all of the remaining Members of this Company do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of member shall have no right to participate in the management of the business and

affairs of this company or to become a Member. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which that member otherwise would be entitled.

**WITHDRAWAL OR REDUCTION OF MEMBERS CONTRIBUTION TO CAPITAL.**

1. A member shall not receive out of the Company property any part of his or its contribution to capital until:

a.) All liabilities of the company, except liabilities to members on account of their contributions to capital, have been paid or sufficient property of the company remains to pay them,

b). The consent of all Members is had, unless the return of the contributions to capital may be rightfully demanded.

c). These Articles of Incorporation are canceled or so amended as to set out the withdrawal reduction.

A member shall be entitled to the return of his or its contribution in the manner provided for in the regulations of the company.

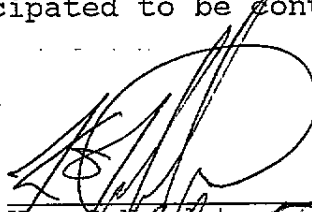

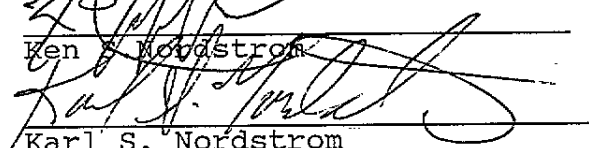
