ARTICLES OF ORGANIZATION

FOR

JND CONSULTING, LLC

The undersigned, as members of a limited liability company adopt the following Articles of Organization.

ARTICLE I-Name

The name of the limited liability company shall be:

JND CONSULTING, LLC

ARTICLE II- Term

The limited liability company shall commence on January 21, 2002 or on the date approved by the Secretary of State and shall continue for thirty (30) years, unless sooner terminated by law or as hereby provided.

ARTICLE III- Purpose(s)

The specific purpose for which the limited liability company is organized are to engage in any lawful act or activity in which a limited liability company may engage, including but not limited to investing in other projects or companies.

ARTICLE IV – Principle place of Business and Resident Agent

The principle place of business of this limited liability company shall be at 6025 Java Plum Lane Bradenton, Florida 34203, or at such other place as the members may from time to time designate.

Additional capital contributions of this limited liability company may be made if agreement is made in writing by the initial members. Any member may assign his/her interest to others with the consent of a majority of other members.

ARTICLE VII – Right and Basis to Admit Additional Members

Additional members may be admitted to this limited liability company with written consent of a majority of members. The offer shall be presented in writing and shall specify the capital contribution necessary to join, but in no case shall the amount be less than the proportionate current book value, i. e., the book value divided by the total of the members proportionate shares. New members shall be effective upon signing the offer sheet and the payment of specific capital.

ARTICLE VIII – Right To Continue



This organization shall have the full authority to continue its existence upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or other such occurrence of any other event that terminates the continued membership of a member in the limited liability company. The remaining member shall have the right to purchase said members interest in the limited liability company for an amount equal to the remaining capital. (including undistributed profits) unless all members approve a written alternative plan to purchase said shares.

ARTICLE IX – Selection of Management

This company shall be managed by a manager, who shall be hired and retained in accordance with the operating agreement. The initial term of the management company shall be five years. The initial manager shall be Jerry Davis.
