**ARTICLES OF ORGANIZATION
OF
CYPRESSWOOD PROPERTY INVESTMENTS, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, being a natural person of at least 18 years of age, acting as organizer, hereby forms a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, Sections 608.401 et seq., as amended from time to time (the "Act"), and adopts the following Articles of Organization for such limited liability company.

ARTICLE I

Name

The name of the limited liability company is **Cypresswood Property Investments, LLC** (the "Company").

ARTICLE II

The period of duration for the Company shall be perpetual.

The Company reserves the right to amend or repeal any provision contained in these Articles of Organization, and any right conferred upon the members is subject to this reservation.
