ARTICLES OF ORGANIZATION

consent of all the remaining members, provided there are at least two remaining members.

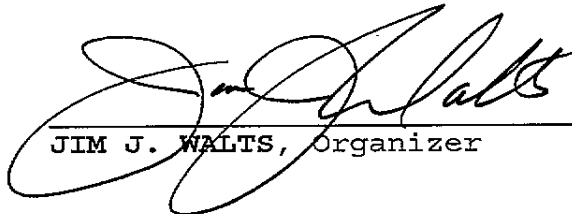
#### ARTICLE IX. MANAGEMENT

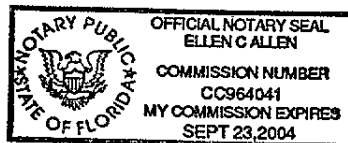
