The Limited Liability Company shall be effective as of March 4, 2002.

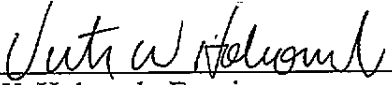
ARTICLE IV: PURPOSE

AND RESIDENT AGENT'S SIGNATURE

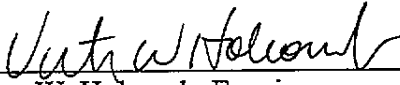
