**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
SASSY DELIGHTS ONE, LLC**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, **Sassy Delights One, LLC**, a Florida limited liability company (hereinafter, the "Limited Liability Company") adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the Limited Liability Company is **Sassy Delights One, LLC**.
