**ARTICLES OF ORGANIZATION
OF
WATER WHIZ, LLC**

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of the limited liability company is Water Whiz, LLC (the "Company").

Additional members to the Company may be admitted only in accordance with the terms and conditions of the Company's Operating Agreement.


