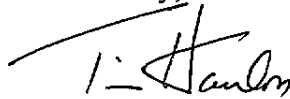

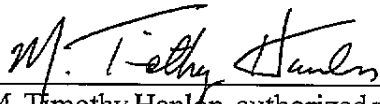
ARTICLE VI - REGULATIONS

ARTICLE VII - AMENDMENT

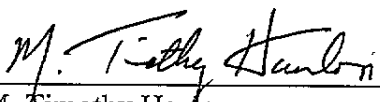
