ARTICLES OF ORGANIZATION
OF
NO-DIG, LLC

1. Name. The name of this limited liability company is No-Dig, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.

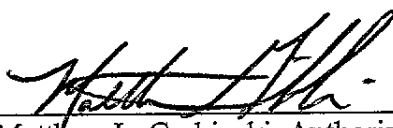
7. Management of the Company. The Company shall be managed by members, in accordance with the regulations adopted by all of the members. The names and addresses of the initial members are:

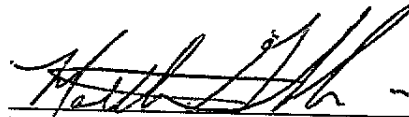
